




Figure 1. Typical RMS Current Dearting





Figure 2. On-State Power Dissipation







Figure 3. Typical On-State Characteristics

Figure 4. Typical Gate Trigger Current versus Junction Temperature






Figure 5. Typical Holding Current versus Junction Temperature

Figure 6. Typical Gate Trigger Voltage versus Junction Temperature





Figure 7. Typical Latching Current versus Junction Temperature
